**TO THE OFFICERS AND MEMBERS OF LOCAL UNION NO. 764
OF THE INTERNATIONAL ASSOCIATION OF BRIDGE,
STRUCTURAL, ORNAMENTAL, AND REINFORCING IRON
WORKERS, ST. JOHN'S, NEWFOUNDLAND**

Dear Sisters and Brothers:

This is to advise that the General Executive Board of this International Association has reviewed information concerning the activities and operations of Local Union No. 764, St. John's, Newfoundland.

The General Executive Board, after careful consideration and deliberation and in order to:

1. Protect the interest of Local Union No. 764 their membership and this International Association,
2. Otherwise carry out the legitimate interests of Local Union No. 764 and this International Association,
3. Assure that Local Union No. 764 will properly perform and comply with the provisions of the International Constitution,

unanimously decided, pursuant to and in accordance with the provisions of Article XII, Section 7 of the International Constitution, to place Local Union No. 764, St. John's, Newfoundland, of the International Association of Bridge, Structural, Ornamental and Reinforcing Iron Workers, under International supervision and control effective as of January 8, 2025. The General Executive Board further decided that beginning as of such date and until further notice, the following shall prevail:

1. All offices of Local Union No. 764 shall be and are hereby declared vacant, including District Council Delegates and Trustees to the various Trust Funds.
2. All regular membership meetings, Executive Committee meetings and other meetings of the Local Union shall be suspended.
3. All business and affairs of Local Union No. 764 will be administered by General Organizer Jimmy Buisson, as the Administrator of Local Union No. 764 and General Vice President Colin Daniels as the Governing Administrator. He shall be assisted by such members as may hereafter be appointed by the General President of this International Association pursuant to Article XX, Section 13 of the International Constitution, and he

shall also be authorized to employ such employees as would normally be required for the proper functioning of a Local Union business office.


4. All officers of Local Union No. 764 are hereby instructed to surrender and deliver immediately upon being notified by letter dated January 8, 2025 to the above-named Administrator, all funds, assets, property, books, keys to the office of Local Union No. 764 records and other documents they have in their possession belonging to Local Union No. 764. Jimmy Buisson, in his capacity as Administrator, is authorized to obtain possession of the aforementioned. All of the aforementioned shall remain the property of Local Union No. 764 and shall be administered by the above-named Administrator in accordance with the applicable provisions of the International Constitution for the benefit and protection of the members of said Local Union.

The General Executive Board requests and specifically instructs the officers and members of Local Union No. 764 to abide by and comply with the decisions and provisions contained in this letter. All of the aforementioned shall become effective January 8, 2025 and shall remain in full force and effect until such time as the General Executive Board takes action amending or terminating any of the provisions of this letter.

The imposition of trusteeship by the International Association at this time, pursuant to Article XII, Section 7 of the International Constitution, is an emergency measure.
